





#### **Target** Acquiror **Acquisition Synopsis** · The ADT Corporation, a leader in security and automation solutions for homes and businesses in North America, has acquired MSE Corporate Security, a NJ-based commercial security integrator MSE provides networked and physical security products, installation and services to education, healthcare, retail, corporate and government clients throughout the U.S. This transaction enhances ADT's expansion of its integrated solutions division and represents the Company's second acquistion since being bought by Protection 1 in May 2016 · WSP Global, a Canadian engineering and professional services consultancy, acquired Leggette, Brashears and Graham ("LBG"), a CT-based groundwater and environmental engineering services firm LBG has 18 regional offices throughout the U.S. and provides expertise in hydrogeology, groundwater and surface water modeling, dewatering and depressurization, environmental investigation and remediation The acquisition will bolster WSP's Water and Environment practice by increasing its groundwater geology capabilities, strengthening its environmental services expertise and expanding its national footprint Clearlake Capital Group, a Santa Monica-based private equity firm, acquired FloWorks International, a supplier of pipe, valves and fittings ("PVF") Headquartered in Houston, FloWorks supplies PVF products from 44 distribution facilities worldwide, serving **W** FloWorks customers in the refining, petrochemical, mining and power end markets The Company distributes products from over 1,900 vendors and serves more than 5,000 customers across North America and internationally · The Carlyle Group (Nasdaq:CG), a DC-based private equity firm, acquired United Road Services, a Michigan-based provider of vehicle transport and logistics services UNITEDROAD THE CARLYLE GROUP United Road hauls more than 3 million new and used vehicles annually for 10,000 plus customers, including manufacturers, retailers, finance and leasing companies, rental agencies and individuals · United Road was a portfolio company of Charlesbank Capital Partners, a Boston-based private equity firm · Genstar Capital, a San Francisco-based private equity firm, has agreed to acquire Institutional Shareholder Services ("ISS"), a provider of proxy advisory and corporate governance solutions, for \$720 million ISS GENSTAR · ISS covers 40,000 shareholder meetings annually, offering recommendations on everything from votes on executive pay to a company's bylaws • ISS was a portfolio company of Vestar Capital Partners, a Boston-based private equity firm


