



Facilities		Service Logic	 Service Logic, a provider of energy and heating services, acquired Modern Heating and Air Conditioning, a Minnesota-based mechanical contracting services provider The acquisition enhances Service Logic's capabilities in maintenance, repair and replacement Sterling Investment Partners purchased Service Logic from Audax Group and The Jordan Company in 2012
Industrial	MMM GROUP	WSP	 WSP Global, one of the world's largest engineering and professional service platforms, acquired MMM Group, a sizable Canadian engineering consulting company, for \$320m (8.9x EBITDA) MMM specializes in transportation, infrastructure, environmental and building services; the acquisition will add 2,000 consultants to WSP and expand its presence in the eastern Canada WSP now has a global workforce of 34,000, which management expects to grow to 45,000 by 2020
Distribution	ATTION ENGINEERS II	Riverside	 The Riverside Company has acquired Arrowhead Electrical Products, a distributor of rotating electrical parts and components, from Pfingsten Partners Arrowhead has completed 8 acquisitions since 2011 to expand its product offering and geographic reach, a trend that is expected to continue with new capital support from Riverside
Logistics	O:L	GEODIS	 Geodis, the giant French logistics and supply chain service provider, acquired Ozburn-Hessey Logistics, a leading US-based 3PL provider in a deal estimated at \$800m (approximately 10x earnings) Previously owned by private equity firm Welsh, Carson, Anderson & Stowe, OHL generates approximately \$1.2 billion in annual sales and employs 8,000 people This sizable cross-border transaction will give Geodis a large logistics footprint in the US, including more than 120 strategically located distribution centers
ВРО	SBC	accenture	 Accenture plc, one of the world's largest providers of business process outsourcing providers, acquired SBC, the management consulting unit of Schlumberger, an energy focused IT and information solutions platform The acquisition will significantly bolster Accenture's presence in the upstream oil and gas industry, where outsourced services and business consulting are in high demand given fundamental market transformations driven by oil price volatility and




