





Restaurant Industry Commentary

TM Capital's restaurant indices traded below the S&P 500 over the last 30 days, while same-store sales and same-store traffic declined by 1.0% and 3.0%, respectively. Bad news again for Chipotle, with the company's stock reaching a new 52 week low following the most recent wave of food safety related concerns. We'll be curious to see how these new incidents affect same store sales for the quarter. M&A and investment activity remains strong – with private equity continuing to lead the way. In particular, **Roark Capital Group** acquired its 20th restaurant brand – the 37-unit **Jim 'N Nick's Bar-B-Q**; and the 200 unit Lebron James linked **Blaze Pizza**, closed on a significant investment from **Brentwood Associates**.







Quarterly Gainers & Decliners by Price Point















