




Restaurant Industry Commentary

TM Capital's restaurant indices outpaced the S&P 500 over the last 30 days, with the exception of Family and Premium Dining, while same-store sales and same-store traffic growth declined by 1.0% and 3.3%. As national restaurant operators struggle to drive traffic, the divergence between these operators and their still growing (but smaller), "platform potential" counterparts is stark. Recent M&A activity tells this story in spades, as private equity snaps up investments in businesses with untapped growth potential and larger operators struggle to protect their market share. Along these lines, M&A activity was strong in May, including the acquisition of **Mountain Mike's Pizza** by a **Levine Leichtman Capital Partners** led investment group, as well as **Balmoral Funds'** and **Gala Capital Partners'** acquisition of **Mooyah**.

Current Restaurant Valuations by Price Point (TEV / EBITDA)





Public Market Performance (Latest Twelve Months)


