- Novartis AG (SWX:NOVN) entered into a definitive agreement to acquire IFM Tre from IFM Therapeutics, Inc. for \$310 million and up to \$1.27 billion in milestones
- IFM Tre is a biopharmaceutical company developing a suite of small-molecule antagonists
- · Novartis AG researches, develops and markets patented prescription medicines and healthcare products worldwide





- Catalent Pharma Solutions, Inc. entered into a definitive agreement to acquire Paragon Bioservices, Inc. from Camden Partners Holdings, NewSpring Capital and others for approximately \$1.2 billion
- Paragon Bioservices operates as a contract research and manufacturing organization that focuses on the development and manufacture of biopharmaceuticals
- Catalent Pharma Solutions, Inc. provides development solutions and delivery technologies for drugs, biologics, and consumer health products





- Elanco Animal Health Inc. (NYSE:ELAN) entered into an agreement to acquire Aratana Therapeutics, Inc. (NasdaqGM:PETX) for approximately \$240 million, a 39.9% premium
- Aratana Therapeutics, Inc. focuses on the licensing, development, and commercialization of therapeutics for dogs and cats
- Elanco Animal Health Inc. develops and markets products for companion and food animals
- Implied Enterprise Value Multiples: 2.7x Revenue, 10.2x EBITDA






- PerkinElmer, Inc. (NYSE:PKI) entered into an agreement to acquire Cisbio Bioassays SAS for approximately \$215 million

- PerkinElmer provides analytical solutions and diagnostic services worldwide






Enterprise Value / LTM Revenue




Enterprise Value / LTM EBITDA



LTM Revenue Growth




LTM Gross Margin*




*EBITDA Margins shown as the gray line.
