- New York City-based private equity firm, The Riverside Company acquired Portland, OR-based outsourced facilities service provider Performance Systems Integration
- Performance Systems Integration provides installation and repair of fire and life safety systems, including fire detection, access control
 and intrusion prevention systems to school districts, property managers and healthcare facilities
- The Riverside Company is an established upper middle market private equity firm, specializing in investing in companies with EBITDA values below \$25 million across a wide array of industries





- Santa Monica, CA-based Boxwood Merger Corp. (NasdaqCM:BWMC) agreed to acquire Austin, TX-based Atlas Technical Consultants, a
 professional industrial consulting and engineering firm, for \$710 million
- Atlas Technical Consultants provides mission-critical technical services that help public and private sector clients test, inspect, certify, plan, design and manage construction projects across the transportation, industrial and other nonresidential sectors
- Boxwood Merger Corp. is a publically traded special purpose acquisition company (SPAC) formed by the management team and its co-sponsor, the Macquarie Group, for the purpose of effecting a merger with a company that provides technical and industrial services





- Myers Industries (NYSE:MYE), operating out of Akron, OH, acquired vehicle parts distributor Tuffy Manufacturing Industries, based in Cuyahoga Falls, OH
- Tuffy Manufacturing specializes in the distribution of automotive and heavy-duty truck service-related parts, tools and accessories to tire
 dealers, retreaders and the truck maintenance and repair industry in the Midwestern United States
- Myers Industries manufactures and sells polymer products to rubber and plastic OEM's operating in the industrial, agricultural, automotive, commercial and consumer markets in North America





- Heartland Express (NasdaqGS:HTLD), based in North Liberty, IA, agreed to acquire Millis Transfer, a provider of regional and transcontinental dry-van truckload carrier services to manufacturers of consumer and industrial products such as glass containers, food products, paper products and beer
- Heartland Express acquired Millis Transfer for an enterprise value of \$150 million, which represents a revenue multiple of approximately 1.0x
- Heartland Express operates as a temperature-controlled and dry-van truckload carrier in the United States and Canada, primarily transporting
 appliances, automotive parts, packaged foods, consumer products and other retail goods for retailers and manufacturers






- Digital marketing and analytics company, REQ, Inc. acquired integrated online marketing solutions provider Internet Marketing, Inc.




Enterprise Value / LTM Revenue




Enterprise Value / LTM EBITDA

EBITDA Multiples Over Time




