- · The acquisition will help Google modernize customers' legacy infrastructure and applications by moving them into the cloud

- The acquisition expands BG's IT staffing roster and adds EdgeRock's outsourced solution center and multi-year customer contracts









#### **Enterprise Value / LTM Revenue**




#### **Enterprise Value / LTM EBITDA**



#### LTM Revenue Growth




#### LTM Gross & EBITDA Margin\*
