- · The acquisition bolsters Inspirage's Oracle ERP Cloud capabilities and its offerings in Finance and Enterprise Performance Management







- The acquisition expands EPAM's expertise in FinTech as well as in other industries with real-time event processing needs





VALUATION TRENDS


Enterprise Value / LTM Revenue




Enterprise Value / LTM EBITDA



LTM Revenue Growth




LTM Gross & EBITDA Margin*
