- The acquisition expands Thrive's Cloud & Cyber NextGen platform into Apex's client base, thereby establishing a presence in the Mid-Atlantic market







- The acquisition solidifies Navisite's position as a leader in managed cloud and ERP services through the addition of Velocity's enterprise application and cloud expertise





VALUATION TRENDS


Enterprise Value / LTM Revenue




Enterprise Value / LTM EBITDA



LTM Revenue Growth




LTM Gross & EBITDA Margin*
