

- GLF&SE offers fire equipment safety, monitoring and installation services for fire extinguishers, alarms and sprinkler systems in commercial, healthcare, municipal and retail facilities
- The acquisition strengthens CertaSite's geographic presence in the Midwest as the company continues to expand its market share by strategic acquisition - GLF&SE represents CertaSite's sixth add-on acquisition in Michigan





- National engineering, architectural and environmental services company Garver has acquired Norman, Oklahoma-based Cabbiness Engineering, a regional industrial engineering services provider
- Cabbiness provides civil engineering and design services for the municipal, water and transportation sectors in Oklahoma including projects for the Department of Transportation and Turnpike Authority
- The acquisition adds Cabbiness' customer relationships and service expertise to position Garver as an industrial services leader in Oklahoma
 while expanding the company's total employee headcount to over 800 across the United States





- Daikin Industries' (TSE: 6367) United States subsidiary, Daikin North America, has acquired ABCO HVACR Supply & Solutions (""ABCO""), a Long Island City, New York-based distributor of HVAC and refrigeration equipment
- ABCO specializes in providing air conditioning, heating, water systems and refrigeration equipment for commercial, industrial and residential applications in the northeastern United States
- ABCO represents Daikin North America's second acquisition of a United States-based distributor following the addition of Stevens Equipment Supply, a TM Capital-led process, in November 2020





- TFI International agreed to acquire the Less-Than-Truckload (LTL) division of UPS, UPS Freight, for \$800m, creating one of the largest LTL service platforms in North America
- UPS Freight, a \$3 billion division of UPS, provides long haul transportation of palletized and heavy LTL shipments, temperature controlled transportation and logistics services throughout North America
- TFI will add over 14,500 UPS Freight employees, now operating under the name ""TForce Freight" TFI intends to improve UPS Freight's profitability and capitalize on the growing final-mile logistics market driven by e-commerce





- Granite Group Benefits offers employee benefits, advisory, insurance, wellness training and risk management consulting services for a broad range of industries in the northeastern United States
- Granite Group will strengthen Alera's footprint and penetration in the Northeast as the company continues to expand its geographic presence nationally - the acquisition represents Alera's fifth acquisition since November 2020




Enterprise Value / LTM Revenue




Enterprise Value / LTM EBITDA
