- Rosewood Private Investments' Superior Environmental Solutions acquired Hydro Technology, a Dundee, Michigan-based industrial facility and environmental cleaning services provider
- Hydro Technology offers industrial & environmental cleaning, water blasting, vacuum and emergency response services for industrial facilities in the Midwest
- Hydro Technology represents Superior Environmental Solutions' second strategic acquisition since Rosewood acquired the business in 2017 and expands its geographic footprint with an incremental fifteen branch locations throughout the Midwest and Southeast United States





- PMC Capital Partners, a Sun Valley, California-based private equity firm, acquired UniversalPegasus, an engineering and construction management services company, from Huntington Ingalls Industries (NYSE:HII)
- UniversalPegasus offers project management, engineering and design services for the oil, gas and power industries with strategic locations in Houston, Texas and Calgary, Canada
- In recent years, UniversalPegasus has expanded its engineering and project management capabilities to become a leading project delivery company, poised for continued financial growth following record-level revenues achieved in 2020





- SunSource, a portfolio company of private equity firm Clayton, Dubilier & Rice, has announced the acquisition of Carotek, a Matthews, North Carolina-based distributor of mechanical and industrial engineering products
- Carotek distributes a broad range of mechanical integration products including flow control, pumps, mixers, seals, piping and tubing to municipalities, engineers and contractors
- Following the acquisition, Carotek now operates within SunSource's Fluid Process Group and adds its extensive geographic penetration in the Mid-Atlantic and Southeast United States to SunSource's national platform





- Seaboard Transportation, a Canadian logistics company focused on bulk truckloads, has agreed to acquire Moncton, Canada-based Armour Transportation Systems, a truckload and rail transportation logistics services provider
- Armour Transportation offers temperature controlled-truckloads, intermodal transportation, parcel delivery and warehousing services for various equipment, minerals and steel loads throughout Canada
- Seaboard Transportation will benefit from the acquisition through meaningful cost synergies and the addition of Armour Transportation's 24 terminals and 4,000+ pieces of equipment






#### **Enterprise Value / LTM Revenue**




#### **Enterprise Value / LTM EBITDA**
