

- · Hunter Technical Resources' engineers specialize in full stack development, machine learning, DevOps, systems architecture

- ACSG deepens SilverSky's portfolio of industry-specific MDR offerings, bringing significant relationships and technological expertise within the K-12 and higher education sector










Enterprise Value / LTM Revenue




Enterprise Value / LTM EBITDA



LTM Revenue Growth




LTM Gross & EBITDA Margin*
