

- Implied Enterprise Value Multiple (2022E): EBITDA: 18x






- Paper Excellence, a global manufacturer of pulp and paper, including printing and writing, packaging, tissue, and specialty papers has

- Implied Enterprise Value Multiple (2022E): EBITDA: 4.1x




INDUSTRIALS GROWTH & VALUATION TRENDS


One-Year Stock Return




One-Year Revenue Growth



LTM Debt/EBITDA




LTM Gross and EBITDA Margins*



*EBITDA Margins shown as the gray line.


