- Blackford Capital Associates, a private equity firm based in Grand Rapids, MI, has acquired Starfire Direct., a DTC fireplace and gas fire pit brand marketed for both residential and commercial applications
- Starfire Direct is the first acquisition in Blackford Capital's Patio Consolidation portfolio which is positioned to be an asset-light, multi-product, omni channel platform offering products within the home outdoor space

(TSX:TOY), a children's toy, game and entertainment company with brands such as PAW Patrol and Rubik's Cube, has acquired 4D Brands International, a Canadian puzzle company that creates 3D model construction kits including cityscapes, landscapes and collectibles from franchises including Star Wars, Disney and Harry Potter
- The acquisition of 4D Brands International allows Spin Master to expand into the innovative 3D puzzle category

- North Castle Partners, a private equity firm, has acquired a majority stake in Nest New York, a home fragrance, personal fragrance and personal care brand, from Eurazeo SE (ENXTPA:RF), a private equity and venture capital firm based in France
- The acquisition will allow New Castle to continue to expand Nest internationally in Europe and Asia and across categories, including having a deeper focus on wellness



- The acquisition of Champion Petfoods will allow Mars Petcare to offer a broader range of premium, specialized pet food brands






Enterprise Value / LTM Revenue




Enterprise Value / LTM EBITDA
