- The acquisition will accelerate The Home Depot's growth with its residential professional customer base



- MiddleGround Capital, a Lexington-based private equity firm, has agreed to acquire The L.S. Starrett Company (NYSE:SCX) for \$136 million






One-Year Stock Return




One-Year Revenue Growth



LTM Debt/EBITDA




LTM Gross and EBITDA Margins*
