- The acquisition expands Rand's service offering into liquid bulk shipping, enhancing its leadership position in the region with comprehensive and specialized capabilities






- Southfield Capital, a Connecticut-based private equity firm, has acquired Business Development Resources ("BDR"), a provider of business coaching and training services for field services contractors

  maintaining its leadership position in the coaching and training industry for field services contractors






### Enterprise Value / LTM Revenue




#### **Enterprise Value / LTM EBITDA**



#### LTM Revenue Growth




#### LTM Gross & EBITDA Margins\*
