




# TECHNOLOGY GROWTH & VALUATION TRENDS

#### **Enterprise Value / LTM Revenue**




#### **Enterprise Value / LTM EBITDA**



#### LTM Revenue Growth




#### LTM Gross & EBITDA Margin\*


